

Are you moving to Louisiana?

State law mandates that once your vehicle has been brought into Louisiana, you have ten days to pay any sales tax due.

To transfer a vehicle to Louisiana which has already been registered in the applicant's name in another state, the following documents must be submitted:

- The original out-of-state certificate of title. If the original certificate of title is being held by a lienholder, a copy of the title or a valid vehicle registration indicating the lienholder's information must be presented with the file.
- Proof of current liability insurance. The insurance company must be authorized to do business in Louisiana.
- Vehicle owner's valid state issued driver's license or identification card must be presented upon registration.

These vehicles will be subject to a road use tax upon registration.

- Road use tax due is based upon loan value of the vehicle listed in the NADA Official Used Car Guide book, or average trade-in listed on the electronic (internet) NADA.com.

When a vehicle is so new it is not listed on the NADA, road use tax due is based on the original invoice price less 15% to determine the current taxable value.

The applicant will have to pay a title fee, plate fee, lien fee (if applicable), and any sales tax due.

The following chart indicates the sales tax credit that will be given:
